STUD DOG CONTRACT



WELFARE

The stud dog owner has taken every care with the welfare of the stud dog. The stud dog owner confirms that to the best of their knowledge the stud dog is both fertile and in good health. The stud dog owner gives no warranties regarding the birth of any puppies arising from the mating(s) covered by this contract.

HEALTH

The stud dog has undergone the following health tests to screen for the following genetic conditions known in the breed:

1. Hip Dysplasia (One off test)
2. BVA Eye Test (Yearly test)
3. Von Willebrands Type 1 & 2 (One off test)

Copies of the results for this stud dog are attached to this contract.

The stud dog owner confirms that they have seen and received copies of all the bitch's relevant health test results.

The stud dog owner will produce the following additional information upon request:

CONSIDERATION FOR THE STUD SERVICE

a) The bitch owner will pay the stud dog owner the sum of £0,000 in advance for the stud service which has taken place on the following dates:

b) The owner of the bitch pays a £000 non-refundable initial payment once the first mating has taken place and on confirmation of the bitch being in pup, the remaining £000 is payable in full.

c) Alternatively, by prior agreement with the owner of the bitch in place of a stud fee, the stud dog owner will have the choice of pick of litter of any puppies produced.

STUD DOG CONTRACT



The stud dog owner undertakes that they will sign and complete all Kennel Club documentation to confirm the date of the mating in the event that a puppy or puppies are produced by the mating and provide any other information regarding the mating that the Kennel Club may require within seven days of a written request to do so.

In the event of the bitch not conceiving the stud dog owner will offer a repeat mating for free within a 14-month period from the date of the last mating with the aforementioned stud dog.
